#### I. **Session Meeting Opening & Roll Call:**

Chair Bacoate opened the Work Session and asked for roll call at 12:05 PM.

HACA Mission Statement and Core Values were read.

#### Approval of Agenda:

Commissioner Goins moved to accept the Special Meeting Agenda as presented. Vice-Chair Collins seconded. All Ayes, No Nays; The Commissioners unanimously approved the meeting agenda as presented.

- Review of Resolutions, Meeting Schedule Change, and Interlocal Agreement with Brevard
  - **Resolution 2025- 07 Approval of Laurel Wood Revenue Bonds**
  - Kristen Kirby explains the resolution, detailing the rehabilitation of Laurelwood apartments and the construction of additional units.
    - Change in lenders requiring new financing documents
    - Project includes rehabilitation of existing units and construction of 54 additional units
    - Bond amount remains the same: \$12,775,000
    - HACA will still receive Issuers fee
    - Anticipated close date is end of June

Chair Bacoate confirms with Kristen that the scope of work and bond amount remain unchanged, with new parties involved due to the change in lender.

Commissioner Harris raises concerns about the developer's plans for working with current residents of Laurelwood. Noemi Riveira explains the relocation plans, including meetings with residents and the involvement of a relocation specialist. She emphasizes the developer's experience with similar projects and their efforts to address residents' concerns.

Chair Bacoate for a motion to approve Resolution 2025-07. Commissioner Roy Harris makes a motion to approve Resolution 2025-07Approval of Laurel Wood Revenue Bonds. Commissioner Kidada Wynn seconds. All Ayes, no Nayy, motion passes unanimously.


